- Implementing Best Practices: Our team works to incorporate accessibility into our design and content processes, including:
 - Providing text alternatives (alt text) for meaningful images and graphics.
 - Ensuring sufficient color contrast between text and background elements.
 - Structuring content with proper heading tags for logical navigation.
 - Designing forms and interactive elements to be keyboard navigable.
 - Writing clear link text and page titles.
- Ongoing Assessment: We regularly review our website using a combination of automated evaluation tools and manual testing to identify areas for improvement.

Conformance Status

The WCAG guidelines define three levels of conformance: Level A, Level AA, and Level AAA. We have set Level AA of WCAG 2.1 as our target standard for this website. We recognize that some content or third-party integrations may not be fully conformant, and we are committed to addressing these areas as we identify them.
